






LOCATION

The property is situated in Stafford town centre on the east side of Salter Street between its junctions with Greengate Street and Market Street and close to branches of CONNELLS and CORALS. The premises are on the main pedestrian route from the substantial car parking element of a nearby new retail development to be occupied, as reported, by B & M, LIDL and PETS AT HOME.

DESCRIPTION

The property forms part of a two-storey development of retail units, has most recently been used as a charity shop and would be suitable for a wide variety of alternative retail purposes or for non-retail use subject to the availability of the appropriate planning consent.

The accommodation provides sales space on the ground floor together with ancillary storage and WC facilities at first floor level and offers an ideal opportunity for an ingoing tenant to acquire a town centre trading presence at a reasonable rental.

SERVICES

Mains water, electricity and drainage are connected.

ASSESSMENTS

The local authority for rating purposes is Stafford Borough Council. The rateable value of the property is £19,250 with uniform business rates payable of £8,970 for the year ending March 2018. These details have been based on the information provided by the Valuation Office's website and should be double-checked by any party intending to enter into any commitment that relies on their accuracy.

EPC

The Energy Performance Certificate issued for this property indicates an Asset Rating of 77 in Band D. A full certificate with recommendations will be provided on request.

TERMS

The premises are available on a new internal repairing lease for a term to be agreed at a rental of **£15,500** per annum exclusive of rates and VAT with upward only reviews to be at five yearly intervals. The landlord will insure the building and then recharge the tenant the appropriate cost thereof. A recharged service charge provision also applies to cover the cost of external maintenance, repair and management.
