LOCATION

The property is situated in a secondary trading position in the town centre just off the main shopping thoroughfare and on the north side of Albion Street close to its junctions with Lower Brook Street and Market Square. The area is characterised by a mixture of local retail and non-retail trades.

DESCRIPTION

The property comprises part of the ground floor of a three-storey office building of brick and tile construction and provides a lock-up retail unit with an aluminium and glazed shop front installed protected by a security shutter..

The premises have previously been used for the sale of fishing tackle and would be suitable for a variety of alternative retail purposes or possibly for non-retail use subject to any planning consent considered appropriate by the relevant local authority but hot food uses will not be considered by the landlord.

ASSESSMENTS

The local authority for rating purposes is Cannock Chase Council. The rateable value is £3,950 with no uniform business rates payable for the year ending March 2023 subject to certain qualifying criteria. The lease is to exclude the security of tenure provisions of the Landlord and Tenant Act 1954. VAT is not applicable on the rental in this instance.
