



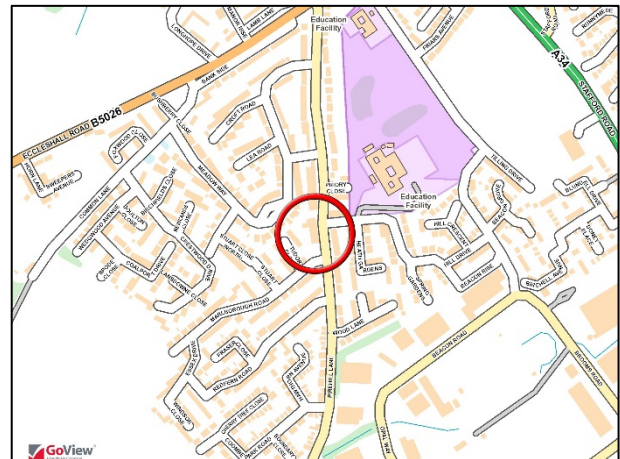

## LOCATION

The property is prominently situated at Walton on the west side of Pirehill Lane on a well-established residential estate located just off the B5026 Stone-Eccleshall Road approximately one mile south from Stone Town Centre.

## DESCRIPTION

The premises comprise a lock-up unit forming part of a modern two-storey neighbourhood parade of eight shops with separately occupied flats above and is constructed in brick with a flat roof.

The accommodation provides a retail area on the ground floor with an aluminium and plate glass shop front and has previously been used as an opticians but would be suitable for a variety of alternative trades and possibly for non-retail uses subject to any planning consent considered appropriate by the Local Authority.

## ASSESSMENTS

The local authority for rating purposes is Stafford Borough Council. The rateable value of the property is £5,300 with no uniform business rates payable for the year ending March 2019 subject to certain qualifying criteria.
