



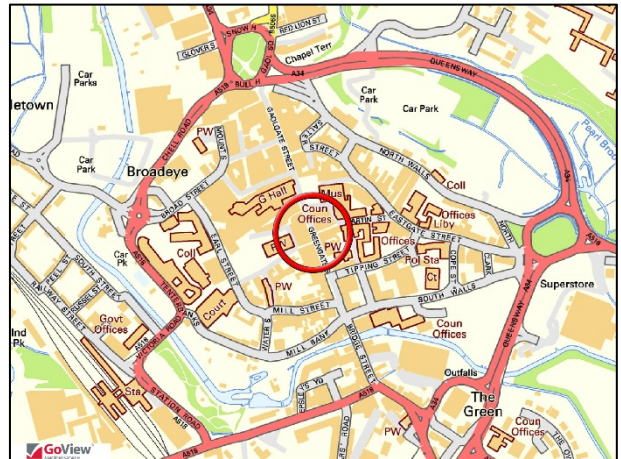
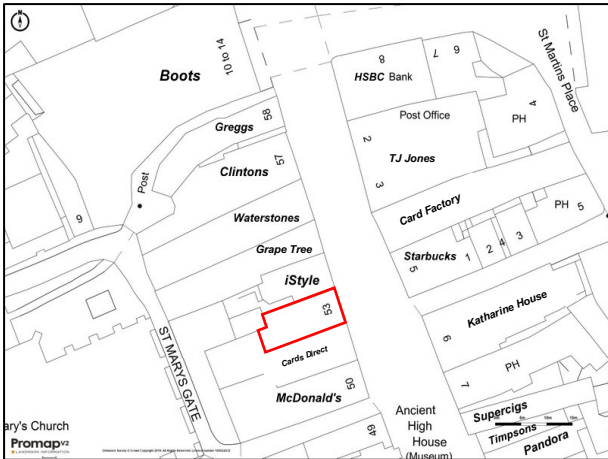

LOCATION

The property is prominently situated in Stafford town centre on the west side of the pedestrianised Greengate Street between its junctions with Market Square and St Mary's Passage and immediately. Branches of MCDONALD'S, SAVERS, STARBUCKS, CLINTONS, TIMPSON, T J JONES and WATERSTONES are in the immediate vicinity.

DESCRIPTION

The property comprises a terraced retail unit of three-storey brick and tile construction with a timber framed shop front and provides a sales area on the ground floor together with ancillary accommodation at first and second floor levels.

The premises are currently tenanted and used as a travel agents with the availability of the freehold interest providing a purchaser with an ideal opportunity to acquire a prominent high street income producing investment located on a part of the town's main trading thoroughfare
